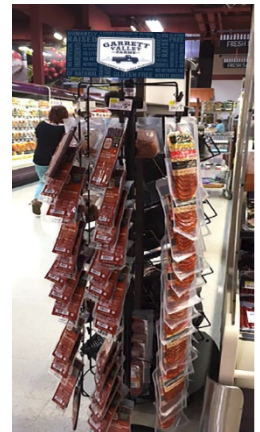
The following is hereby agreed to by and between **Wellshire Farms, LLC. or its subsidiary Companies** and customer.

6. Customer agrees to keep merchandiser clean and operate as per Wellshire Farms, LLC instructions, be responsible for returning merchandiser in the same condition as received, normal wear and tear expected.

7. Customer agrees to be responsible for theft, damage, vandalism, fire, water damage, and any misuse of merchandiser.

8. Customer agrees to be responsible for payment of any personal property taxes, license fees, sales or use taxes related to use of the merchandiser.
